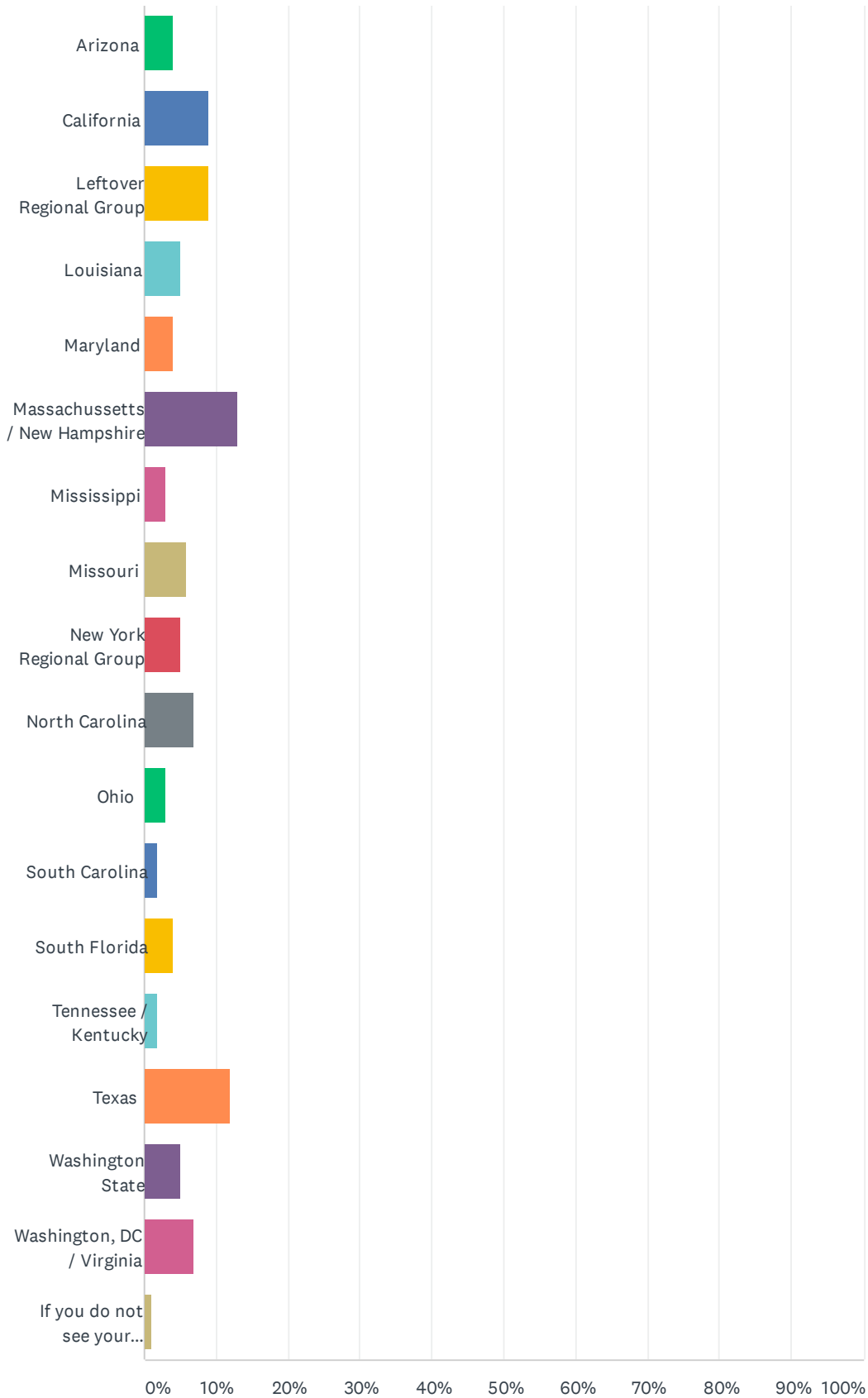

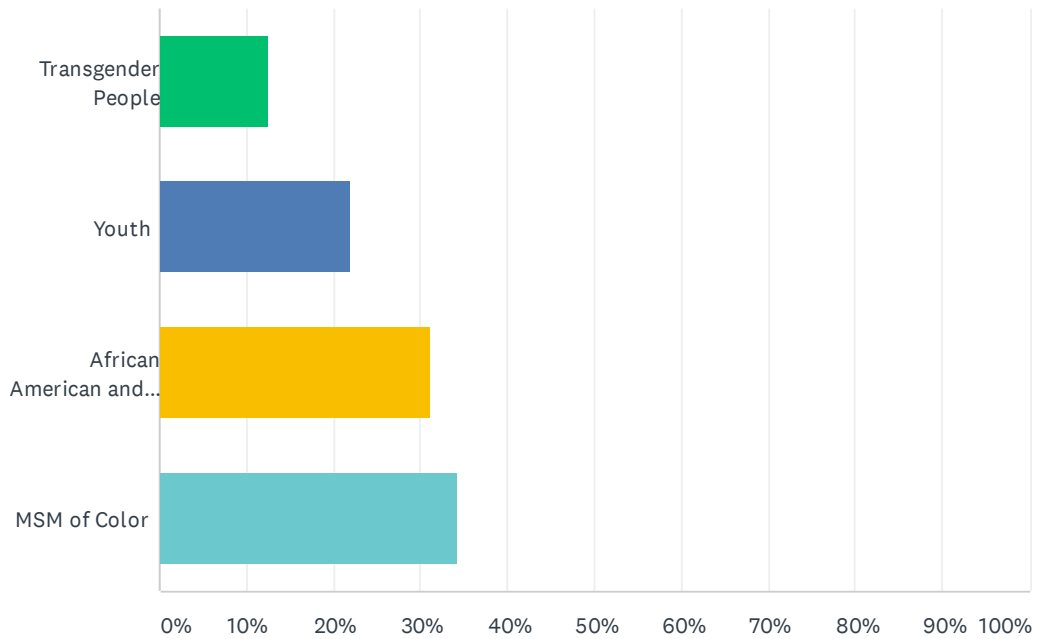

Q6 Which HIV subpopulation have you and your agency chosen for this Collaborative?

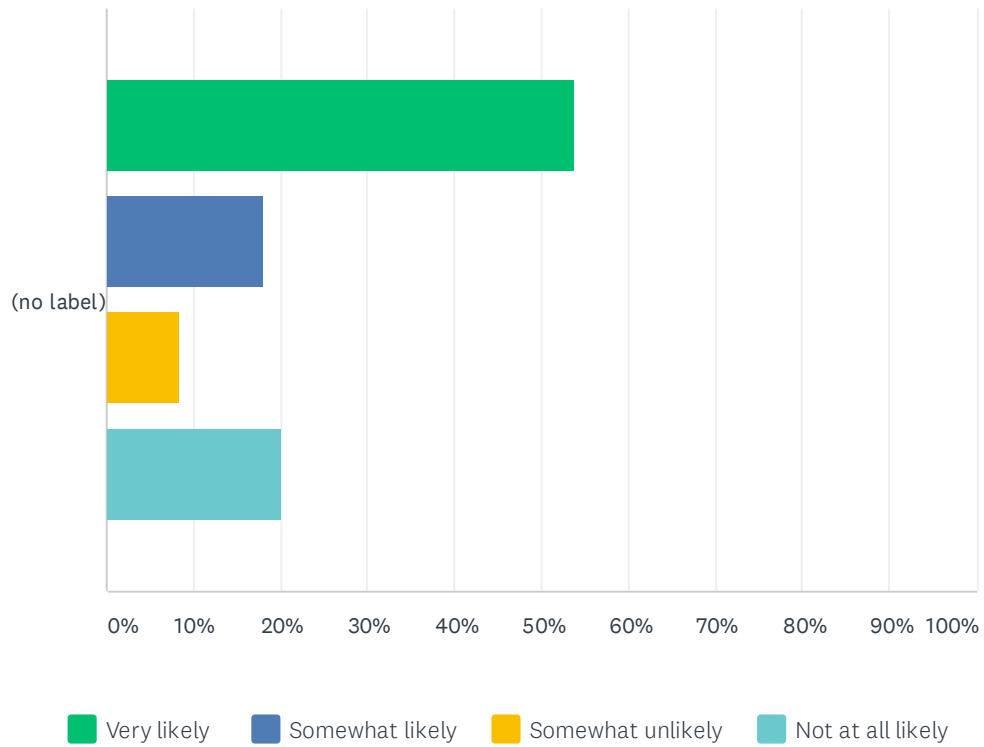

Q7 How likely will you be able to consistently use a webcam for this Collaborative?

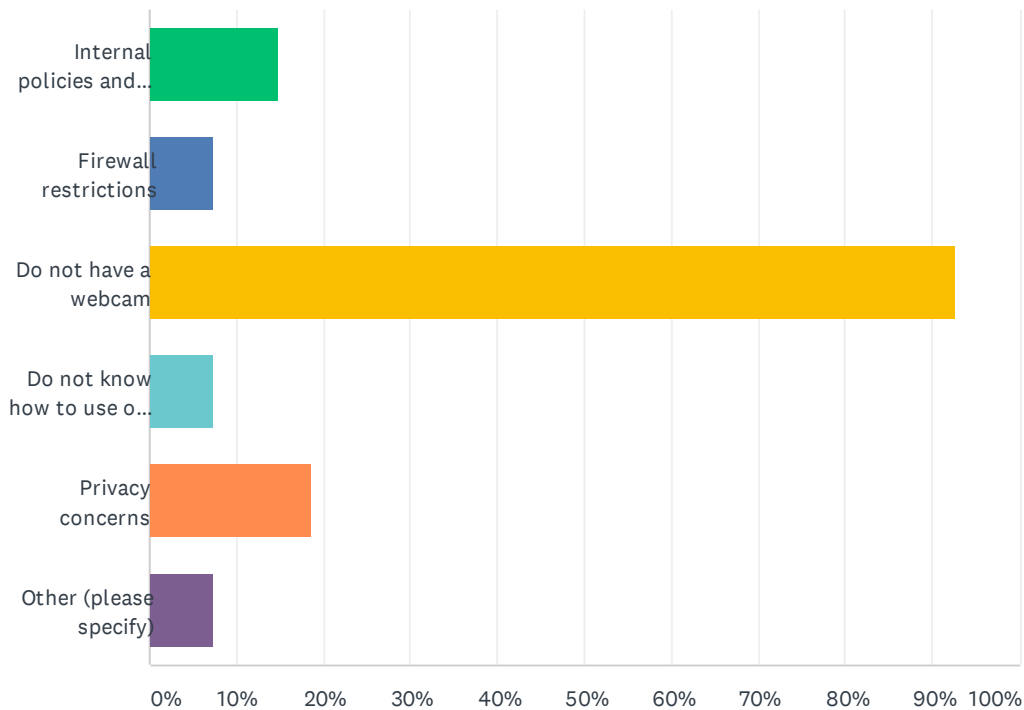

Q8 What barriers would prevent you from routinely accessing a webcam?

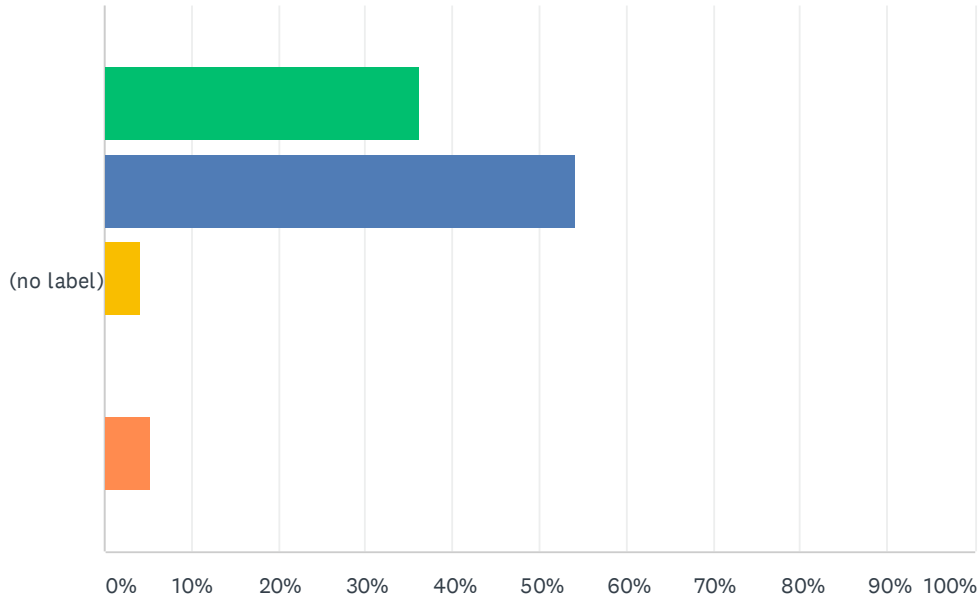

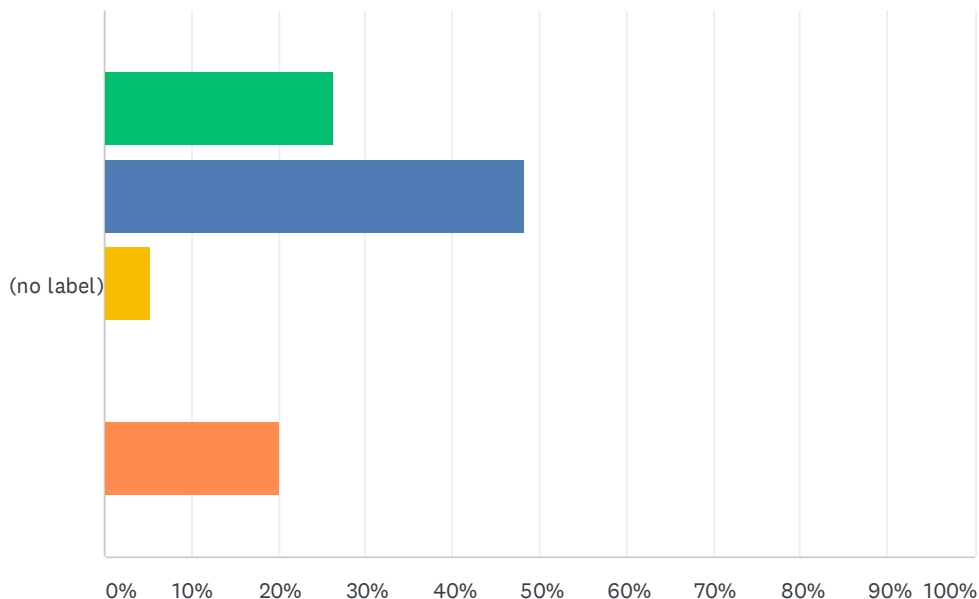

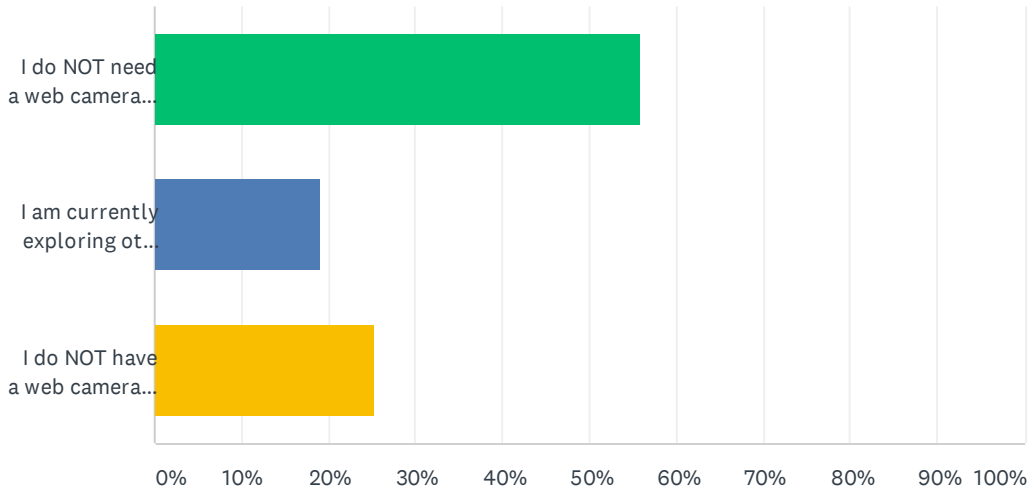

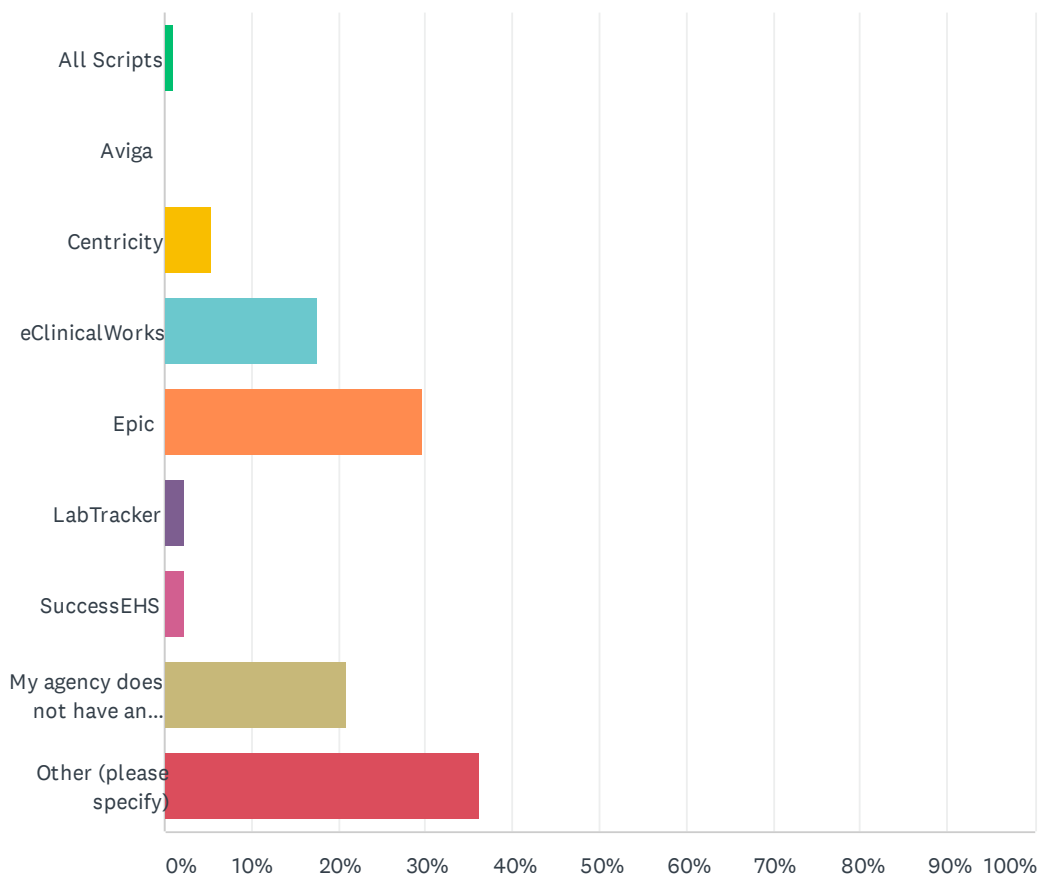

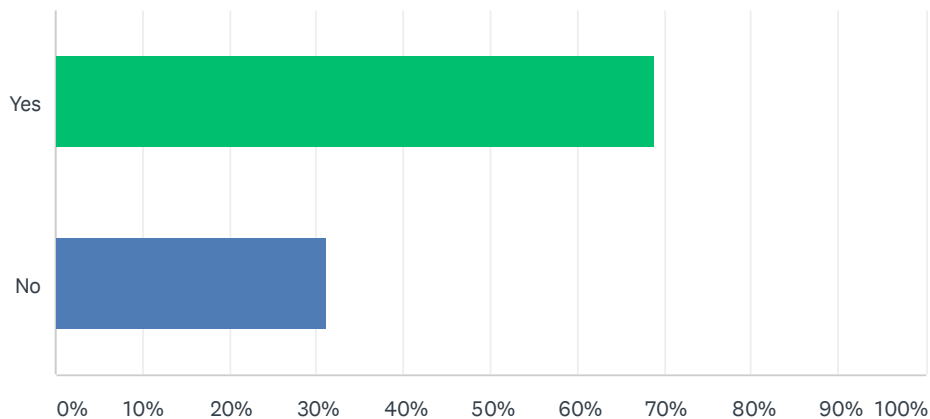

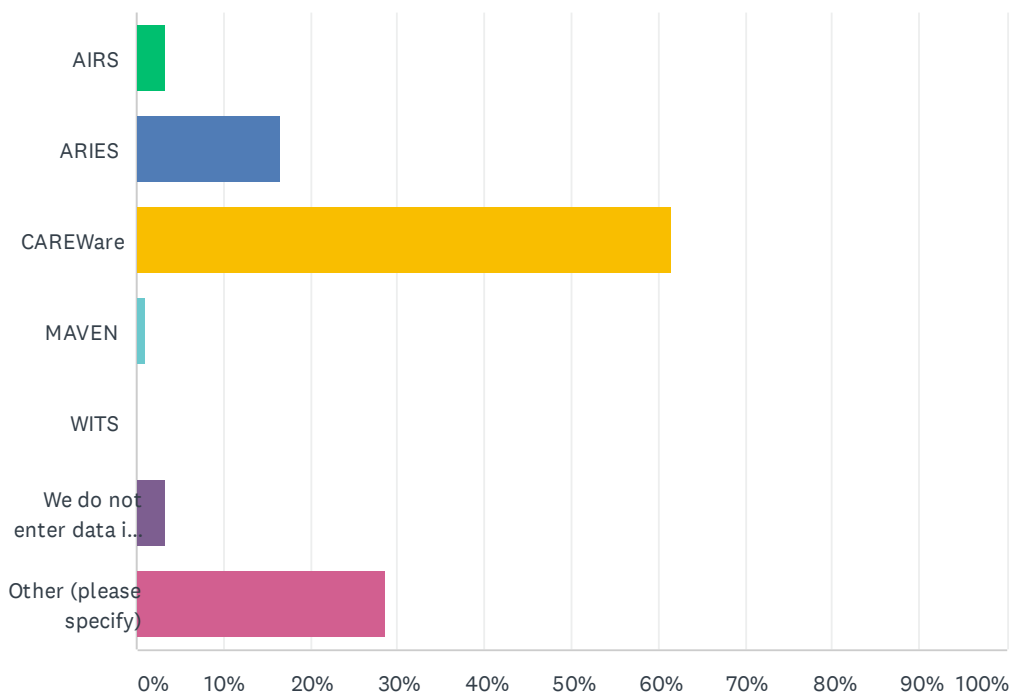

Q14 Does your agency enter data into any of the following data reporting systems?

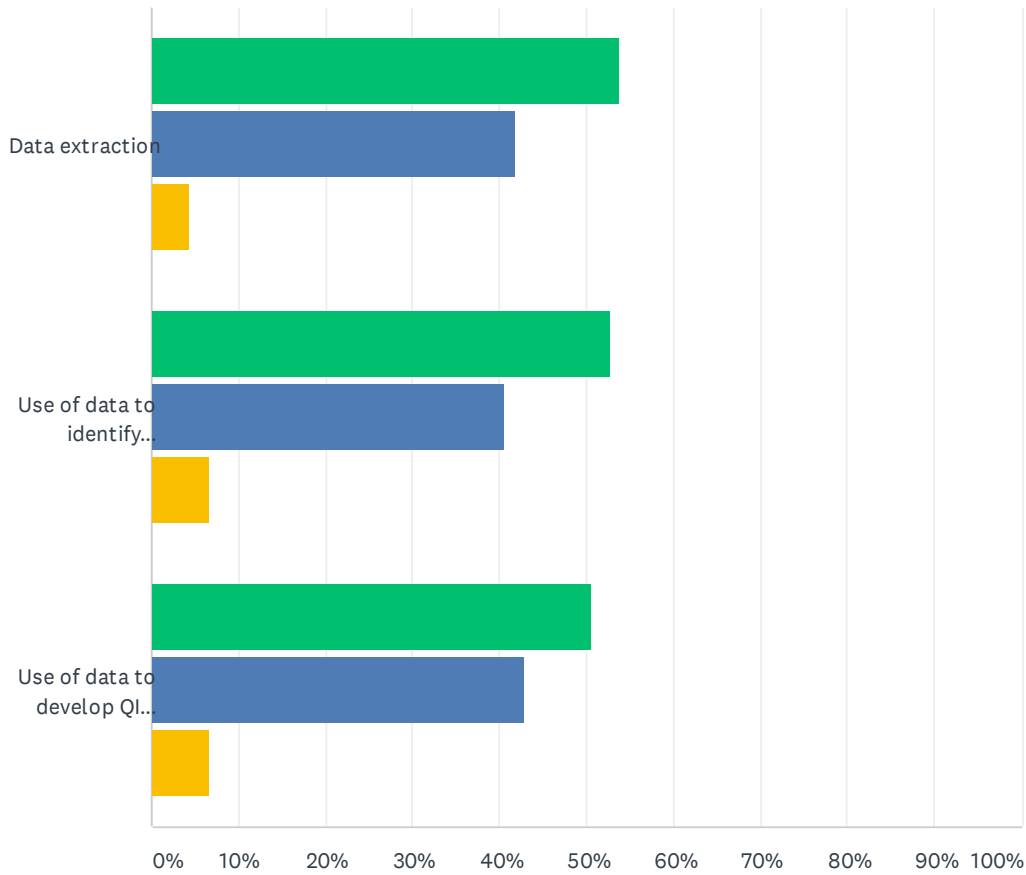

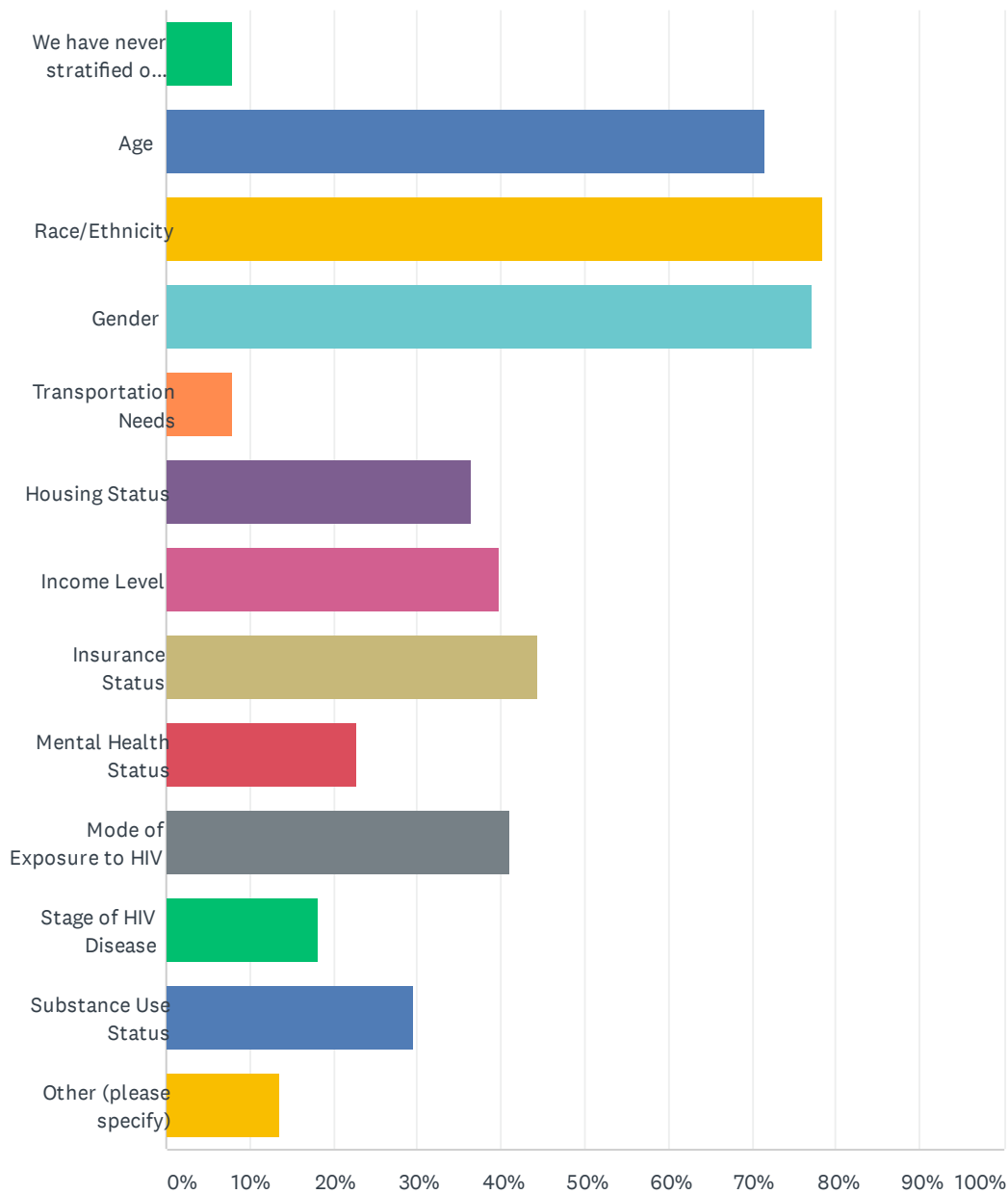

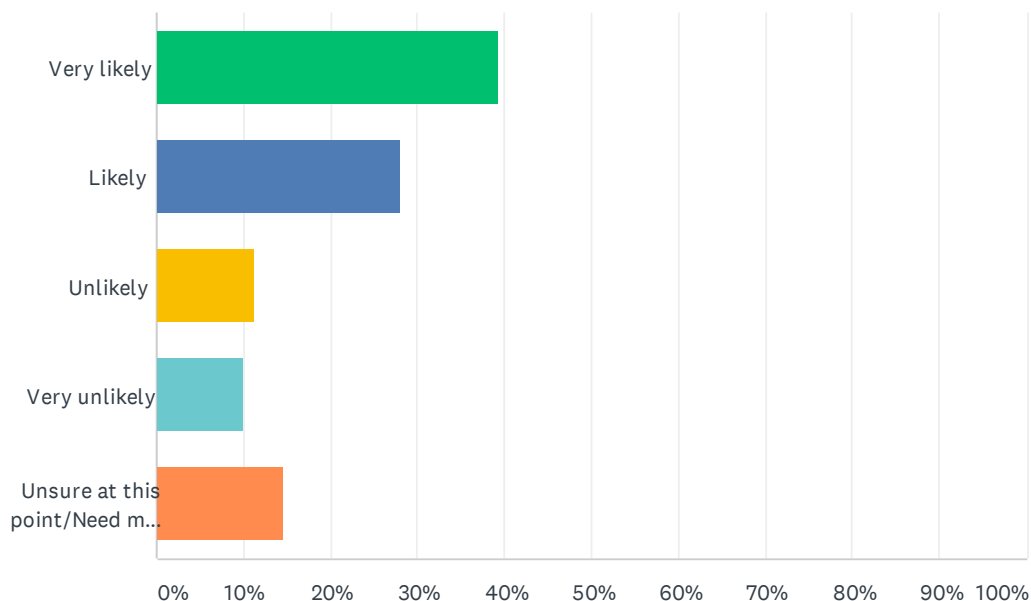

Q17 How likely are you to download and use this mobile app on your smart phone device or tablet? (Please select one)

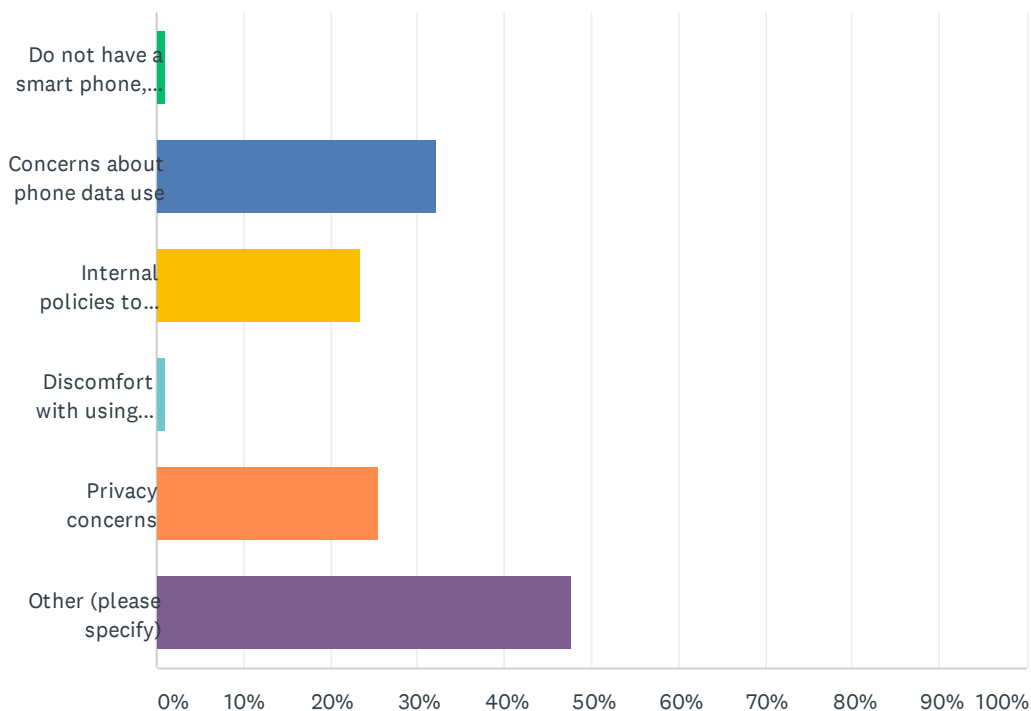
