## Health Resources and Services Administration (HRSA) Overview

- Supports more than 90 programs that provide health care to people who are geographically isolated, economically or medically vulnerable through grants and cooperative agreements to more than 3,000 awardees, including community and faith-based organizations, colleges and universities, hospitals, state, local, and tribal governments, and private entities
- Every year, HRSA programs serve tens of millions of people, including people with HIV/AIDS, pregnant women, mothers and their families, and those otherwise unable to access quality health care





## HRSA's HIV/AIDS Bureau (HAB) Vision and Mission

#### Vision

Optimal HIV/AIDS care and treatment for all.

### **Mission**

Provide leadership and resources to assure access to and retention in high quality, integrated care, and treatment services for vulnerable people with HIV/AIDS and their families.





## HRSA's Ryan White HIV/AIDS Program

- Provides comprehensive system of HIV primary medical care, medications, and essential support services for low-income people with HIV
  - More than half of people with diagnosed HIV in the United States nearly 519,000 people receive care through the Ryan White HIV/AIDS Program (RWHAP)
- Funds grants to states, cities/counties, and local community based organizations
  - Recipients determine service delivery and funding priorities based on local needs and planning process
- Payor of last resort statutory provision: RWHAP funds may not be used for services if another state or federal payer is available
- 87.1% of Ryan White HIV/AIDS Program clients were virally suppressed in 2018, exceeding national average of 62.7%

## Why are Housing Concerns Important to the RWHAP?


- For persons who lack a safe, stable place to live, housing assistance is a proven cost-effective health care intervention.
- Stable housing has a direct, independent, and powerful impact on HIV incidence, health outcomes, and health disparities.
- Housing status is a more significant predictor of health care access and HIV outcomes than individual characteristics, behavioral health issues, or access to other services.


## Clients Served by the Ryan White HIV/AIDS Program, by Housing Status, 2018—United States and 3 Territories<sup>a</sup>

## **Housing Opportunity for Persons With AIDS (HOPWA)**

- Administered by U.S. Department of Housing and Urban Development's (HUD), Office of **HIV Housing (OHH)**
- HOPWA is the only Federal program dedicated to the housing needs of person with HIV
- HOPWA makes grants to eligible cities, states, and nonprofit organizations to provide housing assistance and supportive services to low-income people with HIV and their families
- **Eligible Services:** 
  - Facility-Based and Scattered-Site Permanent Supportive Housing
  - Transitional/Short-Term Facilities

  - **Supportive Services**

## **Health Center Program Fundamentals**



#### **Serve High Need Areas**

 Must serve a high need community or population (e.g. HPSA, MUA/P)



#### **Patient Directed**

 Private non-profit or public agency that governed by a patient-majority community board



#### Comprehensive

 Provide comprehensive primary care and enabling services (e.g. education, outreach, and transportation services)



#### No One is Turned Away

 Services are available to all with fees adjusted based upon ability to pay



#### **Collaborative**

 Collaborate with other community providers to maximize resources and efficiencies in service delivery



#### **Accountable**

 Meet performance and accountability requirements regarding administrative, clinical, and financial operations





## **Health Center Program: National Impact**



#### More than 29.8 million people rely on a HRSA-funded health center for care, including:

- 1 in 11 people
- 1 in 8 children
- 1 in 5 rural residents
- 1 in 3 living in poverty

- More than 395K veterans
- More than 880K served at school-based health centers
- More than 1M agricultural workers
- More than 1.4M homeless





## **Ending the HIV Epidemic**


- 2.7 million HIV tests conducted annually
- More than 196,000 patients with HIV receive medical care services at health centers, including many sites co-funded by the Ryan White HIV/AIDS Program
- Nearly 600 health centers purchase Pre-Exposure Prophylaxis (PrEP) through the 340B Program
- FY 2020: \$54 million awarded in February to 195 health centers to support increased outreach, testing, care coordination, and HIV prevention services, including PrEP, in targeted counties/cities and States



#### **Total Homeless Patients**



- 297 health centers receive section 330h funding (21% of all health centers)
- 5% of all health center patients are homeless (unchanged 2017-2019)







- Direct loans, loan guarantees and grants to develop or improve essential public services and facilities
- Eligible Applicants: Public Bodies, Non Profits, Indian Tribes
- Eligible Purposes:
- Construct, expand, renovate, or improve facilities
- Purchase vehicles ad major equipment
- Associated project expenses
- (eligible professional fees)




