



# Get to know Tarrant County CQM




- CQM program started prior to 2005. In 2011, the CQM program was reenergized.



#### **Performance Measures**



- Performance Measures help to monitor and improve the quality of care they deliver.
  - HIV Viral Load Suppression
  - Annual Retention in Care
- Provide Enterprise has a HAB measure compliance report, which has built-in reports that calculate compliance of the measures and a disparities calculator to assist with determining disparities to care and performance measures for MAI populations.



#### **Performance Measures continued**



•Key performance measures are reviewed at a minimum quarterly, and desktop monitoring is conducted using Provide Enterprise and quarterly chart abstraction.

•Performance measure data is analyzed first by the Grant Coordinator, Quality and Planning, Assistant Quality and Planning Coordinator, Grants Manager, and the Grants and Data Coordinator.

•Performance measure data is shared with Subrecipients, Planning Council, CQM Committee, HIT HIV, and the community at a minimum quarterly but often monthly. Performance Measures help to monitor and improve the quality of care they deliver.



#### **Innovative Solutions**



Mini-HAB is an algorithm written in Python that has the following functionality:


- 1. It can generate major HAB measures such as
  - a. Viral Load Suppression Rates
  - b. Retention in Care Rates
  - c. Prescription on ART Rates
- 2. It assesses a range of populations (through filtering)
- 3. It assesses age groups, zip codes, and for agencies that are Ryan White Funded.
- 4. It can automatically populate reports for agencies to determine for example who is out of care or who is not virally suppressed.
