Optimal HIV care and treatment for all to end the HIV epidemic in the U.S.

Health Resources and Services Administration (HRSA)

Overview



Supports more than 90 programs that provide health care to people who are geographically isolated, economically or medically challenged



HRSA does this through grants and cooperative agreements to more than 3,000 awardees, including community and faith-based organizations, colleges and universities, hospitals, state, local, and tribal governments, and private entities

Every year, HRSA programs serve tens of millions of people, including people with HIV, pregnant people, mothers and their families, and those otherwise unable to access quality health care





HRSA's Ryan White HIV/AIDS Program (RWHAP) Overview

- Provides a comprehensive system of HIV primary medical care, medications, and essential support services for low-income people with HIV.
- Funds grants to states, cities, counties, and local community-based organizations to improve health outcome and reduce HIV transmission.
 - Recipients determine service delivery and funding priorities based on local needs and planning process.
- Provided services to over 566,000 people in 2022—more than half of all people with diagnosed HIV in the United States.
- 89.6% of RWHAP clients receiving HIV medical care were virally suppressed in 2022, exceeding national average of 65.1%ⁱ. This means they cannot sexually transmit HIV to their partners and can live longer and healthier lives.








2023 Administrative Reverse Site Visit Highlights







Division of State HIV/AIDS Programs (DSHAP) Administrative Reverse Site Visit (ARSV)

- DSHAP's ARSV was held November 13 17, 2023
- The ARSV was a hybrid meeting, with in-person attendance at HRSA's Parklawn Building and remote participation via Zoom
 - 120 Part B recipient staff attended in-person
 - 280 people attended virtually
 - All 59 states and territories attended in-person or virtually
- Monday, November 13th was a dedicated meeting day for the Pacific Island Jurisdictions







Division of State HIV/AIDS Programs (DSHAP) Administrative Reverse Site Visit (ARSV)

The ARSV included:

- Three plenary sessions on topics of key importance to Ryan White HIV/AIDS Program Part B programs
- 33 90-minute interactive sessions on a wide range of topics including the AIDS Drug Assistance Program (ADAP), administrative and fiscal operations and clinical quality management
- Three recipient spotlight sessions highlighting innovative programs and practices
- Opportunities for recipients to meet with their project officers and with the Clinical Quality Branch (CQB) team

Integrated HIV/AIDS Planning Technical Assistance Center (IHAP TAC)



- The purpose of this cooperative agreement is to provide technical assistance to Ryan White HIV/AIDS Program (RWHAP) Parts A and B recipients and their planning bodies regarding the:
 - Integration of HIV planning across systems of HIV prevention and care within their jurisdiction;
 - Development, implementation, monitoring, evaluation, and improvement of Integrated HIV Prevention and Care Plans (IPs), including Statewide Coordinated Statements of Need (SCSN), submitted to HRSA and CDC in response to legislative and programmatic requirements.





Access, Care, and Engagement (ACE) TA Center

- The Access, Care, and Engagement Technical Assistance (ACE TA) Center builds the capacity of the Ryan White HIV/AIDS Program (RWHAP) community to navigate the changing health care landscape and help people with HIV to access and use their health coverage to improve health outcomes. Many RWHAP clients are eligible for health coverage options, including Medicare, Medicaid, and Marketplace plans.




RWHAP Compass Dashboards and Benchmarking


