## Background

- Maintaining good oral Health is an important part of maintaining overall health, especially for people with HIV.
- The Arizona and Los Angeles AETCs have been improving training and technical assistance efforts through collaborations for more than 15 years, including programs that assess and address the needs of HIV oral health providers.



# Introduction

- The Arizona and Los Angeles AETCs partnered with Dr. Fariba Younai DDS, PAETC Oral Health Training Director and Dr. Ardis Moe, MD, infectious disease specialist and several community partners to deliver two webinars for Ryan White oral health service providers in our 2 regions, which have differing service delivery models.
- These webinars covered links between oral health and COVID-19, addressed patient and staff concerns about COVID-19 safety measures including vaccines, and discussed oral health services in a post COVID-19 era.
- Because webinar content was relevant to anyone providing HIV oral health services during COVID-19 and these trainings were hosted via Zoom video conferencing, we expanded both webinars to a national audience and offered free dental continuing education units.
- HRSA HAB oral health leadership opened the first webinar held in August 2020. We conducted a follow up webinar when vaccines were widely available and services were reopening in May 2021.

# **Lessons Learned**

- 1. There is an interest in and need for trainings on emerging issues related to HIV care among oral health providers.
- 2. AETCs have an important role in assessing and addressing HIV-related training needs of oral health providers.
- 3. Oral health providers can improve the HIV care continuum by referring patients for PrEP, STI treatment, and testing services. There is a need for linkage between oral health and HIV and STI prevention services.
- 4. Oral health providers can have a positive impact on HIV prevention and care by referring patients to Substance Use Disorder treatment (including MAT) and prevention services.
