# RYAN WHITE HIV/AIDS PROGRAM BEST PRACTICES COMPILATION

PROJECT FACT SHEET

## Project Background

John Snow, Inc. (JSI) has been contracted by the Health Resources and Services Administration (HRSA) HIV/AIDS Bureau (HAB) to develop and implement the **Ryan White HIV/AIDS Program (RWHAP) Recipient Compilation of Best Practice Intervention Strategies**. This project is funded by the Minority HIV/AIDS Fund (MHAF). JSI has partnered with Mission Analytics to develop a comprehensive, online compilation of RWHAP recipient and subrecipient best practice intervention strategies. The online recipient compilation will be housed on **TargetHIV.org** and structured to allow programs to easily search and identify RWHAP best practices.

## What will be included in the Compilation of Best Practice Intervention Strategies?

Criteria to identify RWHAP Parts A-D best practice intervention strategies for the compilation will be guided by an implementation science framework. The ultimate goal is to systematically document existing strategies and interventions that have been shown to improve HIV outcomes in a 'real world' setting and can be replicated by other programs.

The compilation will draw upon existing HRSA HAB and RWHAP recipient and subrecipient best practice intervention strategies that yield the best health outcomes and public health impact. Additional novel, emerging, and innovating strategies will be a major focus of this project with selected best practices identified and documented through site visit data collection.

## How will the best practice intervention strategies be collected?

RWHAP recipients and subrecipients will submit strategies and interventions that they have found to be effective in improving outcomes along the HIV care continuum. The online submission mechanism will be available on the TargetHIV.org website.

- Developed draft emerging strategy submission form
- Created OMB package for submission form and program feedback visit materials

- Created emerging strategy submission form
- Conduct communications/outreach
- Review emerging strategy submissions
- Identify sample and conduct up to 30 program feedback visits
- Test, analyze, and document criteria to identify strategies from program feedback visits

### YEAR 3

SEPTEMBER 2020 - AUGUST 2021

- Develop and launch online compilation of emerging strategies on TargetHIV.org
- Promote and disseminate the online compilation
- Monitor use of online compilation
