ADAP Data Report (ADR) Release 8.0 Merge Rules

The Acquired Immunodeficiency Syndrome (AIDS) Drug Assistance Program (ADAP) Data Report (ADR) is a web-based application that allows a recipient to upload multiple client-level data Extensible Markup Language (XML) files. Once uploaded, data contained in these XML files are merged based on the client's encrypted Unique Client Identifier (eUCI).

If the client's record in the ADR system is missing a value from a data element reported in the new client-level data XML file, the ADR system will save the value. If the client's record in the ADR system has a value for a data element, the following rules are used to merge the data:

- **Update if Blank:** If the value for an element is missing (or blank), it is replaced with the new value from the newly uploaded file.
- **Append if New:** If an element can accept multiple values and a new value is contained in the newly uploaded file, this value is added.
- Yes: If the value reported for a Boolean element is different from the value recorded in the newly uploaded file, "Yes" is recorded. For example, a recipient uploaded a client-level XML data file to the ADAP application with a client who's "New Enrollment Flag" was reported as "No". Later, the recipient uploads another client-level XML data file with the same client (based on the client's eUCI) who's "New Enrollment Flag" was reported as "Yes", the system will record "Yes".
- **Most Recent Date:** If the value reported for an element that accepts dates is different from the value reported in the newly uploaded client-level data XML file, the most recent date is recorded.
- Oldest Date: If the value reported for an element that accepts dates is different from the value reported in the newly uploaded client-level data XML file, the value with the oldest date is recorded.
- **Highest Value:** If the value reported for an element is different from the value reported in the newly uploaded client-level data XML file, the highest value is recorded.
- **Merge by Priority:** If the value reported for an element is different from the value reported in the newly uploaded client-level data XML file, the value is recorded based on its priority.
- Merge by Method: In some cases, a special method has been defined by HAB for a specific data element.
 These rules are unique to the data element. Refer to the merge rule descriptions for an explanation on how the data elements will be merged in the ADR system.
