2022 ADAP Data Report (ADR) Changes

When will the changes go into effect?

Health Resources and Services Administration HIV/AIDS Bureau (HRSA HAB) is implementing changes to the ADR that will be **effective for the 2022 ADR submitted in June 2023.** A summary of some of the changes can be found below, with all detailed changes outlined in Tables 1 on the following page. Table 1 also includes some schema information to assist ADAPs until the updated <u>ADR XML Schema Implementation Guide</u> is released.

What changes will be made?

There are two reporting changes for the 2022 ADR:

- Last Date of Eligibility Confirmation: The first change is to reflect updated guidance in HRSA HAB's <u>Policy Clarification Notice (PCN) 21-02</u>. Per this PCN, ADAPs are still required to recertify clients but are no longer required to follow the every "6-month" recertification criterion. Given this, Recertification Date will be changed to Last Date of Eligibility Confirmation. ADAPs should report the latest date of eligibility confirmation. The data element is only required for existing clients and only one date should be reported per client; the date can precede the reporting period.
- Medication Days Supply: The other change reflects the return of a data element that was reported prior to the 2021 ADR: Medication Days. The reporting requirement is the same as it was historically; ADAPs should report the number of days for each medication dispensed to a client during the reporting period.

What should I do to prepare for reporting changes?

Here are some useful steps to take to ensure that you're prepared for the upcoming changes:

- Make sure you are collecting the required data for any client-level data elements which have updated response options
- If you use an ADR-Ready System to create your client-level data XML file, check the <u>ADR-Ready Systems Status</u> page on TargetHIV early in 2023 to see if they've completed the necessary updates for 2022 reporting. If you don't see your vendor on this list, contact your system representative or the <u>DISQ Team</u> to check in about updates.

Who can I contact for help?

There are several <u>TA providers</u> contracted by HRSA HAB who are available to all RWHAP recipients and providers to assist with ADR reporting. <u>TargetHIV</u> also has the largest library of ADR TA resources available including the <u>ADR Instruction Manual</u>, <u>webinars</u>, and other
