## Context: Changes to the Louisiana Healthcare Landscape

#### Louisiana Medicaid

- Louisiana Department of Health (LDH) administers the Office of Public Health and Bureau of Health Services Financing (Medicaid)
- Transition to Managed Care model in 2010
- Medicaid Expansion

#### Privatization of Louisiana's public hospital network

- Louisiana State University (LSU) hospitals provided direct patient care for the majority of state's indigent citizens
- Also provided healthcare for the many of state Ryan White clients
- In 2012, state officials announce landmark public-private partnership agreements for LSU hospitals
- Severe disruption of LSU hospital-based HIV care network



# How did the collaboration between the Louisiana Office of Public Health, STD/HIV and Medicaid programs come about?



#### **OPH/Medicaid Data Sharing Agreement**

Historically a few OPH Programs had negotiated their own data sharing agreements with Medicaid, but many programs had no access to Medicaid data

Change in leadership at Medicaid three years ago facilitated process to establish an agency-wide data sharing agreement

Support of OPH Assistant Secretary

Process took only six months

Signed data sharing agreement in Feb 2014

All users complete an annual "Data Sharing User Agreement"





## "Healthy Louisiana" Incentive-based Performance Measures

- Healthy Louisiana plans have 8 incentive-based performance measures
- Viral load measure included in latest RFP (based on HRSA/HAB HIV viral load suppression measure—National Quality Forum # 2082)
- Plans penalized \$250,000 annually if VL measure is not achieved

## Healthy Louisiana VL Measure Current Matching Process

- Now conducting quarterly matches between Medicaid claims and OPH HIV Surveillance data
- Individual-level data are provided back to each Healthy Louisiana plan for their clients only

## **Out of Care Initiative**

Participants to define and generate out of care patient list

Share with SHP program to identify 'true' out of care

#### Adopt Gap Measure

Gap in HIV medical visits:

Percentage of patients, regardless of age, with a diagnosis of HIV who did not have a medical visit in the last 6 months of the measurement year

Numerator: Number of patients in the denominator who did not have a medical visit in the last 6 months of the measurement year

Denominator: Number of patients, regardless of age, with a diagnosis of HIV who had at least one medical visit in the first 6 months of the measurement year





## Disparities, 2013

13-24 year old Black MSM:

69% in care

61% in care are virally suppressed

45-64 year old White MSM:

75% in care

86% in care are virally suppressed





## Louisiana Medicaid Expansion

- First official act of Governor John Bel Edwards was to expand Medicaid effective July 1, 2016
- Louisiana has already added more than 260,000 new adults to Medicaid
- All enrolled in one of five Healthy Louisiana Medicaid Managed Care Organizations
- Eligibility for Medicaid in LA **before** Medicaid Expansion:
  - Parents required to have income less than 25% of the federal poverty level
  - Only pathway to Medicaid for person without minor-aged child was disability
  - Managed care membership consisted primarily of children/youth under age 19, women (most of them only during pregnancy), and people with serious physical and/or mental disability
  - State implemented the Affordable Care Act family planning only program in 2015 and began enrolling males—STI screening and testing were also a covered benefit
- Innovative strategies used by state to rapidly enroll newly eligible adults
- State expected managed care plans to contract with Ryan White providers:
  - Language included in contract amendment
  - Regular reporting on contracting status
  - Topic of discussion at onsite Readiness Reviews prior to "go live"

## LDH and MCO Partnership

#### Improving HIV Measures

- Prematurity Reduction Performance Improvement Project (PIP)
- Measure:
  - HIV and Syphilis Screening in Women During Pregnancy
- Description:
  - The percentage of women who had at least one test for HIV during pregnancy
  - The percentage of women who had at least one test for syphilis during pregnancy



# LDH and MCO Partnership

#### Improving HIV Measures

- LDH Office of Public Health HIV Committee
  - Amerigroup Louisiana participates in the HIV Committee with providers and community organizations
  - Educates providers on STI screenings incentive
  - Educates providers on resources provided by Amerigroup to members and providers (e.g., incentives, Disease Management program, Case Management programs)
  - Contracted with all Ryan White providers in Louisiana



# **Provider Incentive for HIV Screening**

Through the Amerigroup Enhanced Primary Care provider incentive program, PCPs are rewarded with increased reimbursements (% above the fee schedule) for providing the following incentivized care.

Incentivized Care	Code(s) Billed
HIV screening	G0432, G0433, G0435
Antibody; HIV-1 and HIV-2, single result	86703



### **Presentation of PrEP Data**

- On April 28, 2016, Amerigroup was invited to present its PrEP coverage
- Our data shows that 102 of our 115 members prescribed Truvada® are HIV positive
- This number, along with the data presented, indicates that PrEP is not widely used among our high-risk members

- A54.6 Gonococcal infection of anus and rectum
- <u>Z72.52</u> High risk homosexual Behavior
- <u>Z20.6</u> Contact with and (suspected) exposure to human immunodeficiency virus (HIV)
- Z72.53 High risk bisexual behavior
- <u>Z72.51</u> High risk heterosexual behavior




## High Risk Encounters - Place of Service

# **HIV Case Management**

- On May 16, 2016, Amerigroup organized a workgroup to develop a comprehensive case management and medication adherence program for Louisiana
- Workgroup includes subject matter experts from Clear Health Alliance, a specialized MCO for HIV in the state of Florida
- Workgroup also includes representatives from CrescentCare, a Ryan White provider in network with Amerigroup Louisiana

- Meeting every two weeks, the workgroup had presentation from ViiV Healthcare on the pharmaceuticals programs on HIV on May 31, 2016
- The group also heard from Primary Care Development Corporation a presentation on Approaching HIV Prevention in Louisiana on June 13, 2016
- This CM Program is important with Medicaid expansion and carving in of the justice-involved population starting next month




# Gender

#### **HIV Positive Members by Age**


