What is Community Planning?

- Community planning consists of a public participatory and usually interactive form
 of town or neighborhood planning in which diverse community members (often
 termed "stakeholders") contribute toward the formation of goals, objectives,
 planning, fund/resource identification and direction, planned project
 implementation and reevaluation of documented local planning policy
- Community planning often promotes public/private partnerships as a way to expand the development of activities in support of the goals defined by the community
- Community planning seeks community consensus for proposed allocation of scarce resources among competing demands. Community members grow by sharing a complex community information base, directly informing local plans, influencing resulting budget development as well as helping coordinate the work of local jurisdictions



RWHAP Planning PLWH Opportunities

- RWHAP legislation strongly supports continuous PLWH input across the HIV Continuum of Care
- On-going Needs Assessment (Annual Assessments, Integrated HIV Prevention and Care Plan, including the Statewide Coordinated Statement of Need, Service Utilization, PLWH Health Outcomes)
- Planning Councils, Advisory Bodies, Community Planning Groups, subcommittees, Quality Improvement Committees, consumer satisfaction surveys, focus groups, town hall meetings





RWHAP Planning Key Questions for Grantees

- Are services improving health outcomes (retention/engagement in care/access to ARV/viral load suppression)?
- Does the service utilization data; the analysis of treatment adherence to ARVs; HIV medical visits; and viral load suppression rates reflect the demographics of the epidemic? Are there disparities?
- If health disparities exist, are there more in-depth mechanisms for input from PLWH that is needed to address these disparities?
- Is data being utilized to inform decisions on planning, service delivery, new interventions or to develop new service delivery models or access points?





RWHAP Planning Capturing the PLWH Voice and Experience

- Multi-faceted, multi-dimensional mechanisms to engage PLWH input across demographic factors, risk factors, regions and along all points of the HIV Care Continuum
- On-going outreach, training and development of PLWH on Planning Councils, Advisory Bodies, Community Planning Groups, Integrated HIV Prevention and Care Planning Bodies, Quality Improvement Committees & all sub-committees of these bodies
- Consumer forums, consumer surveys and consumer satisfaction surveys





RWHAP Planning Key Questions for PLWH

- Along the HIV Continuum of Care, what services are available and are services being utilized? Are these services accessible? Are services culturally competent? Are these services responsive to the needs of PLWH? Do these services improve health outcomes across the HIV Continuum of Care?
- Are there service gaps? Are there services that needed, but not available to PLWH? What are the range of services PLWH need in order to improve their health outcomes?
- Are there changes to HIV Services along the HIV Continuum of Care since the implementation of the Affordable Care Act (ACA)?





What are Successful Examples of PLWH in RWHAP Planning?

- Clinic-level, local city/county level and State-level
- Consumer surveys, town hall forums, consumer focus groups
- Membership on planning, quality improvement, and advisory groups
- Training opportunities in planning for PLWH
- How have services changed with PLWH input
- Have client-level health outcomes improved
